However, the above university is not eligible to receive any assistance from University Grants Commission and any other sources funded by the Government of India under Section 12 (B) of the UGC Act, 1956.

Subject: Proposal for 12-B status.

Sir,

This has reference to the proposal submitted by the University for 12-B status and subsequent visit of the UGC inspection Committee to consider the proposal. The report of the inspection Committee alongwith the compliance submitted by the University was placed before Committee of UGC members for consideration. The Committee recommended as under:-

"The Committee considered the report of the UGC's inspection Committee along with the compliance report submitted by the University in respect of the observations/suggestions given by the Committee and decided to recommend approval of 12 B status to Integral University (Private University), Post Bas-ha, Kursi Road, Lucknow (Uttar Pradesh).

The University is advised to get NAAC accreditation at the earliest."

The above recommendations of the Committee along with the Report of the UGC inspection Committee were placed before the Commission in its 506th meeting {Item No. 1.02(a)(ii)} held on 03rd February, 2015. The Commission noted and approved the recommendations of the Committee. The 12 B status is granted to the University subject to the condition that the financial assistance under all UGC schemes shall be limited to those relating to teachers and students only.
